### Important Information Please Read Northeast Guide Service, LLC d/b/a Northeast Whitewater Waiver and Release of Liability

In consideration of Northeast Guide Service, LLC furnishing services and/or equipment to enable me to participate in kayaking, canoeing, wildlife tours, overnight trips, swift water rescue, outdoor leadership courses, whitewater rafting or any activity associated with Northeast Guide Service, LLC. I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers, and hazards and such exists in my use of whitewater equipment and my participation in whitewater activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers, sub-contractors, or agents of Northeast Guide Service, LLC the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision-making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a raft, canoe, or kayak and such other risks, hazards, and dangers that are integral to recreational activities that take place in a wilderness, outdoor, or recreational environment; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, sub-contractors, or employees of Northeast Guide Service, LLC or by any other person.

I, on behalf of myself, my personal representatives, and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify Northeast Guide Service LLC, Northeast Whitewater, U.S. Rafting Inc.
